FALL TERM COURSES:

Principles of Microeconomics

ECTS: 8

Course description:

This course offers a comprehensive introduction to the principles of microeconomics, emphasizing their application in understanding real-world economic issues. Academic Writing and Research in Economics

Course description:

The course encompasses a range of skills and concepts crucial for achieving success in academic writing, with a particular focus on economics. It aims to develop the ability to express economic theories, arguments, and empirical findings precisely. Various techniques and methodologies essential for academic excellence in economics are explored, including literature review, data analysis, argument construction, and the clear communication of intricate economic concepts. Emphasis is placed on enhancing writing clarity, structure, and style and fostering critical thinking and analytical skills required to create high-quality research papers and articles in economics.

Behavioral Economics

Course description:

This course offers an exploration into the cognitive processes behind economic decision-making. The course bridges the gap between psychology and economics, providing students with insights into how emotions, context, and cognitive biases influence the economic choices of individuals and institutions. It challenges the traditional economic assumption of rational decision-making, delving into why people sometimes make irrational choices, and how they can be predictable in their unpredictability.

Moral Foundations of Society

ECTS: 4

Course description:

This course explores the ethical aspects of social theory and practice and the uncomfortable yet omnipresent questions of moral considerations in our lives and decision making. Its

fundamental rationale is the dictum of the philosopher Jan Patočka, reiterated by thinkers from Adam Smith and John Locke to political practitioners such as Margaret Thatcher, that “no society... can function without a moral basis, which is not a matter of opportunity, circumstances or anticipated benefits.” We will explore the different hypotheses and theories about the sources and roots of moral behaviour in our evolutionary past, in the judeo-christian tradition, the reasonings of Plato and the philosophers of Antiquity, the theories of British empiricists and liberal thinkers John Hume and Adam Smith, the idealistic perspective of Immanuel Kant, the rejection of morality by Karl Marx and Friedrich Nietzsche, the reflections of the traumas and horrors of the 20th century in the works of Levinas, Patočka and others, all the way to the contemporary liberal perspective of morality as a form of justice by John Rawls et al. We will apply the knowledge derived from the classical texts to present-day concerns with the environment, inequality, social justice and the emerging mega-phenomenon of artificial intelligence.

Data-Driven Decision-Making in Economics and Business

Course description:

The course aims to give students the fundamental information and abilities needed to evaluate and comprehend data to make strategic decisions. Statistical analysis, predictive modeling, and data visualization techniques are covered in this course, with an emphasis on their practical applications in business and economic situations. Students will gain knowledge on how to use data analytics tools to drive policy formation, comprehend market trends, optimize operations, and make well-informed judgments. Learners will apply theoretical principles to real-world circumstances through practical projects and case studies, equipping them for data-driven problems in their professional careers.

Course description:

This course focuses on the role played by economic factors on a national and global scale, security and foreign policy. Economic conditions and activities have a profound impact on countries' strategic strategies interests, especially about the interconnectedness of today's

world. This course is designed to help students understand these effects, the challenges they pose to modern societies and the ways governments address them. Topics covered in this course include major power competition, trade, technology, economics sanctions, the military-industrial complex, industrial espionage, money laundering and terrorist financing.

Objectivism and Cinema

ECTS: 4

Course description:

Introduction to the works of Ayn Rand, the definitions and outline of Objectivism, as well as its contemporary interpretations and significance. The seminar will also explore applications of her philosophy to religion, foreign affairs, current events – and any areas of student interest.

Critical reading of Rand's works, individual evaluation of her ideas, as well as of her critics' and opponents' multi-disciplinary philosophical arguments. The course is based on her non-fiction essays (primarily from 'Virtue of Selfishness') but recommended literature and material includes her fiction as well as documentaries and movies based on her novels. The course aims at pursuing critical reading skills, as well as fostering presentation and self-expression skills in students through individual assignments as well as through discussions. The evaluation takes that into consideration.

Global Economy Studies

ECTS: 5

Course description:

The aim of the course is to provide students with a comprehensive understanding of the interconnectedness of the world economic order and explain the process of shaping the world economy of today. Students will also learn how to compare key economic factors of global economy. In addition to a systemic approach, students will also be introduced to a comparative method of comparative economics. Based on a combination of knowledge about key historical contexts and together with knowledge of current economic events, students will learn to analyze current and future trends in the world economy.

Corporate Finance 1

ECTS: 5

Course description:

This course introduces the fundamental concepts and tools of corporate finance. Students will learn about the role of financial managers, financial statement analysis, and the basics of financial planning and capital structure. The course covers key topics such as the time value of money, valuation of bonds and stocks, risk and return analysis, and short-term financial management. Emphasis is placed on applying these concepts to real-world financial decision-making in corporations.

Civil Society and the Public Sphere in the EU

Course description:

The main objective of the course is to acquaint students with the similarities and differences of contemporary European civil societies and to examine the role of cultural, social and political factors in the processes of European public sphere formation within the process of

European integration. In the first part stress will be laid on the description and interpretation of presently existing varieties of European civil societies. The course will help the students to understand the main historical roots of European plurality, i.e. the political, economic and cultural processes that engendered this plurality. In the second part the pivotal theoretical concepts of civil society and public sphere will be discussed and applied to a transnational (European) level. The role of civil societies' plurality in relation to the quest for a European civil society and European public sphere will be explored and examined.

ONLY FOR MA STUDENTS: International Private Law and International Business Law

Course description:

This course offers a comprehensive introduction to the core principles of private international law and international trade law. The lecture series will commence with an overview of the subject matter and sources of private international law. Subsequent sessions will explore international contract law and the frameworks for the resolution of international commercial disputes. The final two sessions will be dedicated to a critical analysis of the significance of international organizations within the framework of international trade law.

ONLY FOR MA STUDENTS: Macroeconomics

Course description:

The aim of this course is primarily to enable students to gain a deeper understanding of macroeconomic processes and to provide them with a solid theoretical foundation for the

study of applied economic disciplines. During the course, students will learn the logic of economic thinking and develop their ability to formulate and present their own opinions and positions on key issues of current economic development.

ONLY FOR MA STUDENTS: Challenges of European Governance

ECTS: 4

Course description: TBA

Our discussions will be mostly framed within the pivotal theoretical concepts of good governance, public sphere, collective identity, and bordering. These theoretical concepts will be introduced and discussed in relation to a European level. Main objectives of the course are to acquaint students with the similarities and differences of contemporary civil societies in the EU. We will examine the role of cultural, social, and political factors during the processes of the formation of European nation states, their public spheres and collective identities. Emphasis will be placed on explaining the variety of contemporary European civil societies. The course will help students to understand the main historical roots of European plurality, including the political, socioeconomic, and cultural processes that engendered such plurality. We will further discuss main cultural and political preconditions (including policies) accompanying and guaranteeing the process of Europeanization and how to make the EU more legitimate, accountable and responsive to the needs of its citizens? Special attention will also be paid to the role of borders, bordering and its transformation in the EU. By the end of the course, students will have gained (1) understanding of variety of civil societies in Europe; (2) theoretical orientation in debates on the European governance and a European civil society formation; (3) empirical knowledge of the key factors of European public sphere/s and civil society formations; (4) competence in discussing main challenges and perspectives of further development of the European governance and its key factors including political sphere, public sphere, collective identity and civil society.

ONLY FOR MA STUDENTS: Economic policy of European Union

ECTS: 5

Course description:

This course broadens students' knowledge of the economic policy of the European Union, its structure, objectives and influence on member states and the global economy. Students will learn about key aspects of EU economic policy, including the single market, Economic and Monetary Union, fiscal policy, common agricultural policy, regional policy and competition policy. Furthermore, the course will deal with EU trade policy, energy policy and digital single market strategy. Particular attention will be paid to the EU budget, the system of economic governance and the EU's response to the financial crisis in 2008. This course is designed for students interested in the European economy and its links to the global economy.

ONLY FOR MA STUDENTS: World Economy

This course provides a comprehensive view of the dynamics and structure of the world economy. It focuses on the key factors and principles that influence global economic growth and development. During the course, students will learn about the main economic indicators, theories and models of international trade, monetary systems and the role of technology in the global economic context. The course also examines the impact of international corporations and the process of globalization on the world economy. The course provides a deeper understanding of the current and future challenges facing the global economy, including financial crises and the unequal distribution of wealth and resources. This course is

suitable for students of economics, international relations, political science and anyone interested in international economic issues.

ONLY FOR MA STUDENTS: Selected Issues of Political Philosophy

Course description:

The course introduces students to selected topics and issues in political philosophy that simultaneously resonate with current political and ethical public issues and dilemmas. The scope of the course will be based on the European history of ideas. The main emphasis will be laid on the principles and challenges of liberal and democratic societies and on the task of sustainability of liberal democracy in the rapidly changing conditions of the contemporary world.

ONLY FOR MA STUDENTS: Open economy macroeconomics

ECTS: 3

Course description:

The course is mainly devoted to the analysis of international economic relations and its impact to national economies. Factors behind all balance of payments accounts are analyzed as well as and exchange-rate determination theories. The first part presents some traditional approaches to international economic relations and trade policies, followed by the balance of payments, the Mundell-Fleming model and finishing with the monetary approach to international economic relations analysis. The second part deals with the different theories of exchange rate determination, from the most conventional one (purchasing power parity) to the most "modern" theories, embodied in the monetary and portfolio models. The third part

is devoted to the discussion of the pros and cons of different exchange-rates regimes (cf. the theory of 'optimal currency areas'). The last part deals with policy co-ordination issues.

ONLY FOR MA STUDENTS: Great Thinkers in Political and Economic Thought

Course description:

The aim of this course is to introduce some of the key works of great thinkers of political and economic thought, which laid the foundation for understanding reality, organizing our thoughts and developing civilization. The course will focus on classic and groundbreaking works whose insights are applicable and instructive today.

ONLY FOR MA STUDENTS: Money, Banking and the Financial System

Course description:

This course is designed to provide students with a comprehensive understanding of the workings of the monetary and financial system. It will begin with basic concepts regarding the role and functions of money in the economy, including its use as a medium of exchange, store of value, and unit of account. Students will learn about the banking system, its structure, role and importance in the economy, as well as the process of money creation and the money multiplier. The course continues by examining monetary theory and the functions, instruments and implementation of central bank policy and its objective and effects on the economy.

Introduction to Financial Systems

This course provides a comprehensive overview of the financial systems, illustrating the various components, operations, and the role they play in the economy. The curriculum is designed to equip students with the knowledge to analyse financial trends, assess risks, and make informed decisions in the financial sector.

Comparative Economic Policies

Course description:

The course systematically analyzes the reasons and consequences of public policies. It deals with the economic justification of arguments for state interventions in market functioning. Upon successful completion, students will be able to analyze a wide range of government interventions in the economy, including their unintended consequences. Specifically, the abilities include: understanding the difference between market and bureaucratic management, identifying the structure of actors' motivations in cases of individual public policies, understanding the problem of intended and unintended consequences in specific cases and identifying them, identifying the influences of interest groups on the form of public policies and institutional changes, understanding the dynamics of processes within the public sector.

International Finance and Trade

Course description:

This course delves into the complex world of international finance and trade, offering insights into how global markets operate, the mechanisms of international financial transactions, and the principles governing international trade. The curriculum aims to equip students with the skills to analyse international financial flows, evaluate trade agreements, and understand the impact of global economic events on countries' economies. Particular emphasis is placed on analysing emerging markets, international capital flows, and the intricacies of trade financing. In this topic, we also delve into critical aspects such as the balance of payments, global economic integration, and the role of trade organizations. This subject equips students with the knowledge to navigate the complexities of sustainable international finance and trade, incorporating ethical considerations into contemporary practices.

Public Finance and Budgeting

International Communications: origins modern trends and outlines

Course description:

The main goal of the course is to figure out global political and media outlines. The tutor examines the creation and development of leading political and media flows, and, to be more certain, the media state in existing political conditions and its current transition. A peculiar attention is focused on media globalization and manipulation affected by the contemporary political priorities. Also, the issue of media rights and responsibilities in existing political conditions looks very important for investigation of modern political and media trends. Finally, the tutor examines new media outlines related to the BRICS countries and its influence on the world. Thus, the course serves as both instructive and informative for strengthening the world view of students and their better reflection of humanity tendencies in the world space.

Introduction to Political Problems of Globalization

Introduction to Money and Banking

Business Economics and Market Analysis

Conflict Regions in the Current World

Course description:

The main goal is to provide students with a complex knowledge of current conflict areas what includes the history, geopolitical circumstances and key decision-making processes. What are the origins, present and future of conflicts around the globe? Can we predict new conflicts? Can the West prevail in the war on terror? What are the main insurgencies and how to fight them? Former Yugoslavia, Former USSR, Middle East, Afghanistan and Pakistan, Northern Africa, Islamic Immigration to Europe, Central Africa, Southern Asia and the War on terror in general. Lectured by former head of Czech Provincial Reconstruction Team in Afghanistan and long-year correspondent from the Balkans.

Political and Economic Landscape of Central Europe

Course description:

This course offers an in-depth exploration of the political and economic landscape of Central Europe, focusing on the historical, contemporary, and emerging trends that shape the region's political and economic dynamics. Students will gain insights into the unique socio-political and economic structures of Central European countries, their integration into European and global systems, and the challenges and opportunities they face in the 21st century. Through a

blend of theoretical frameworks and case studies, the course aims to equip students with a comprehensive understanding of the interplay between politics and economics in Central Europe.

Advanced Comparative Thinking on Authoritarian Resurgence Worldwide

ECTS: 4
Teacher: Doc. Pelin Musil, Ph.D.

Course description:

This course examines the global rise of authoritarianism and processes of autocratization in the 21st century. It introduces students to key concepts, theories, and empirical debates on how authoritarian regimes emerge, function and stabilize, often through formally democratic institutions. Drawing on comparative politics and international perspectives, the course explores classic and “new” forms of authoritarian rule, including competitive authoritarianism, and analyzes the strategies autocrats use to maintain power through legitimation, co-optation, and repression. The course further situates authoritarianism in a global context, focusing on how major powers such as Russia and China diffuse authoritarian practices beyond their borders, and how democratic opposition engages in different forms of resistance against authoritarianism.

Post-communist political systems

Course description:

The course provides a general overview of political systems in post-communist European countries, while focusing on a central question: What does “post-communism” actually

mean, and how has the communist past shaped—and continued to shape—political institutions and public political attitudes across the former Soviet Bloc?

Political Economy in Asia

Course description:

The course examines the core issues of political economy in the Asian region. Asia is approached not only as one of the central geopolitical hotspots of the contemporary world, but also as a key engine of the global economy. The primary objective of the course is to introduce students to the major economic trends shaping the region and to explain how these trends influence political decision-making by regional actors, with broader implications extending to North America and Europe. The course covers topics such as the rise and growing dominance of the Chinese economy; the first- and second-generation of the so-called Asian Tigers/Dragons (including South Korea, Hong Kong, Singapore, Vietnam, Indonesia, and others); global value and supply chains; technological competition between the United States and China; and a concise overview of the region's economic development from the colonial period to the present. Attention is also devoted to political-economic relations between the Czech Republic / the European Union and selected Asian countries.

The Rise of Illiberalism and Authoritarianism: A Comparative Introduction

Course description:

This course provides an introductory overview of the global trends in illiberalism, authoritarianism, and democratic backsliding. Students will explore the causes, processes, and consequences of democratic decline, focusing on case studies from Europe, the United States, and beyond. Through lectures, readings, discussions, and student presentations, participants will examine key concepts such as populism, polarization, competitive authoritarianism, and the role of resistance actors. The course emphasizes comparative analysis to understand how global and regional factors shape contemporary political systems and democratic resilience

Introduction to Decision-making in Economics, Business and Politics

Course description:

90% of the world's data has been created in the last 2 years (source: US Chamber of Commerce). With this massive influx of information, the human decision-making process has become both more complex and vital to successful decision outcomes. When Adam Smith “the father of modern economics”, wrote his seminal work in economics (“The Wealth of Nations”) he laid out the principles that laid the foundation of classical economics. But a lot has changed since he wrote the book back in 1776 (!). Two very notable variables have entered into decision making: 1) the sheer volume of data an economist, business executive and political scientists have to deal with, and 2) the “human element” of economic decision making. As an example of #2) might be if someone gave you two free concert tickets for you and your teenage daughter to see Taylor Swift, and it started to rain just as the concert began. If you left with her at the first few raindrops.....well, good luck with that. The “utility” of that free ticket to you might be minimal, but to your daughter it might be a vastly different story. Another dynamic; how to filter out irrelevant data (the white noise) to make effective decisions. We will explore and try to provide answers to these dilemmas, and utilize modern tools and theories (statistical analysis, AI, etc) to enable human decision makers to optimize

utility, parse the data, and focus their energies on resource optimization and creative ways to improve their business.

Econometrics and Applied Statistics

ECTS: 5

Course description:

This course introduces the fundamental concepts and tools of econometrics, applied statistic and machine learning for analysing economic, business, and political data. Student will learn how to collect data, transform them, and use them in their analysis. Next, the students learn basic models such as regression, panel data models, time series data and models of unsupervised and supervised learning. They will learn how to use such models, their advantages, and disadvantages and what is their optimal usage. Emphasis is placed on practical usage of the models on real data, how to explain them to common audience and preparing students for advanced studies and professional careers in their fields.

Between the West and the Middle East: Why Religion Matters In International Politics

Course description:

Theologian and scholar Paul Tillich claimed that religion is "the state of being grasped by an ultimate concern, a concern which qualifies all other concerns as preliminary and which itself contains the answer to the question of the meaning of our life." Whether or not we are religious ourselves, it is hard to argue with Tillich's estimation of the impact of religions on human social, cultural, and political orientation. This course makes a case for the value of

religious literacy—that is, knowledge of, and the ability to understand religion—particularly for those who study foreign relations between Europe and the Middle East. Keeping in mind that: religious expression is different from the critical study of religion, that religions are internally diverse and change over time, and that religion informs all aspects of human activity, we will explore why religious literacy is essential to successful relations between the West and the Middle East.

Cohesion Policy

This course on Cohesion Policy delves into the European Union's strategies for promoting economic, social, and territorial cohesion among its member states. Students will explore the theoretical underpinnings, implementation practices, and impacts of cohesion policy, gaining insights into its role in shaping regional development, enhancing competitiveness, and supporting structural adjustments in member states. Modern Policy Making

Course description:

As policy making has been forced to adapt due to dramatic changes in business, political, and economic landscape, it may be a precursor to even faster change ahead. Just in the past decade alone, we've witness: The impact Brexit has had on the UK and the EU. The 2016 election of Donald Trump as President of the United States (a 100/1 odds outsider one year prior to the election). The insurrection at the US Congress. The impact of social media; both positive from a perspective of rapid dissemination of news and the broad choice of media perspectives, and negative from a fake news and technology deepfakes. The Russian invasion of Ukraine; and the political, physical casualties, and emigration crisis that followed. The impact of Covid-19 on the world; both from a health and economic standpoint. The impact of \$500B to \$1T companies (Apple, Amazon, etc) on news dissemination, political influence; and the decline of "traditional" news sources: radio, newspapers, etc. If I can take out my iPhone and ask Siri for directions to CEVRO, programming Siri to listen in on everything I say can't be far off (if it's not already). All this has (or will) have a profound impact on future policy making.

Introduction to Private Law

Course description:

This course offers an in-depth exploration into the fundamental aspects and structures that underpin private law. Designed for students seeking to understand the legal frameworks governing private relationships, this course covers a range of critical topics. AI and Ethics

Course description:

The seminar uses the example of artificial intelligence (AI) to explain the importance of Rand's virtue ethics. The recent public discourse on imbuing AI with ethical premises highlighted just how important moral philosophy is for human flourishing – and how unsolved our competing ethical systems are. Even for human use, but definitely for machines. According to virtue ethicists, such as Rand, philosophy has a duty to illuminate and guide real life. Applying various branches of philosophy are part of the job. Accordingly, Ayn Rand's moral philosophy and epistemology have a lot to say about artificial intelligence development. This seminar aims at introducing students to the philosophy of Ayn Rand with special emphasis on the application of her virtue ethics on the field of AI.

It focuses on political analysis to shape policy, from conflict prevention through conflict management to conflict resolution, as well as topics such as preventive diplomacy, transparency of diplomatic practice, foreign policy, international relations and others. It will also educate students about the more mundane, yet necessary aspects of being a diplomat.

Game Theory and Strategic Decision-Making

Course description:

The course provides students with conceptual tools for analyzing strategic decision making.

These tools are applied to topics from the fields of economics, business and politics.

Course description:

Upon successful completion of this course, students will be able to: • distinguish between various branches of social science, economics and legal scholarship in particular, • compare variant institutional arrangements (settings) with respect to an existing property rights structure, • identify economic, social and cultural incentives and constraints for prospective changes in the nature and structure of property rights, • specify the role of the state ownership of the means of production, • identify the differences and similarities between the process of nationalization and its inverse – privatization, • understand consequences of a wealth inequality for the tension between the haves and the have-nots.

ONLY FOR MA STUDENTS: Social Research and Scientific Methods

Course description:

Students will become familiar with the key principles and techniques of statistical analysis and their use in research within the social sciences. The course covers a wide range of topics, including formulation of research questions, sample selection, data collection, descriptive statistics, inferential statistics, regression analysis, analysis of variance, and multivariate statistical methods. The course also emphasizes the importance of ethical approaches in the conduct and presentation of statistical research, including the correct interpretation and processing of statistical data. One of the main aims of this course is to provide students with practical skills and an understanding of how to apply statistical methods to social research. Emphasis is placed on the practical use of statistical software. This course is suitable for students of economics and political science and other fields that require solid knowledge of statistical methods for analyzing social data. Presumed knowledge includes basics of statistics and social research.

Course description:

This course provides a comprehensive look at how political systems influence economic decision-making. It will examine how different types of political systems, from democracies to autocracies, shape fiscal and monetary policies, trade policies, economic development decisions, and other key aspects of economic policy. The course focuses on theoretical concepts such as rational choice, behavioral economics and public choice. In addition, it also deals with specific topics such as political corruption, economic inequality, political regime change and transitional economies. This course is suitable for students of economics, political science, international relations and other fields who are interested in how politics and economics are related. Presumed knowledge includes a basic understanding of macroeconomics and political theory.

ONLY FOR MA STUDENTS: Globalisation - economical and social conflicts

Course description:

This course offers an exploration of various aspects of globalization and provides an understanding of their economic and social conflicts. Course description:

This course focuses on how political science and economics has dealt with institutions in the past, and how it deals with institutions in the present, and what this means for the explanations of institutional persistence and change in the political and economic world. The analysis of institutions from the perspective of political science will focus on the

development of different approaches to institutions over time, addressing among others the differences between traditional or ‘old’ institutionalism, on the one hand, and the more contemporary or ‘new’ institutionalism, on the other. We will also explore why institutional analysis has shifted from explaining institutions to explaining their effects.

ONLY FOR MA STUDENTS: Migration and its economical and political impacts

Course description:

This course provides an overview of key concepts in the economics of immigration. It is divided into two parts. The first part contains basic theoretical models. In other parts, attention is paid to the practical effects of migration in the entire spectrum of its influence. Attention is also focused on the specifics of European migration, its typology and asylum policies.

ONLY FOR MA STUDENTS: Law of European Union

ECTS: 3

Course description:

The aim of the course is the introduction of the basics of EU law to students, both by introducing the institutional law of the EU and the main areas of substantive EU law. Firstly, lectures will focus, in particular, on supranational character of the EU, membership in the EU and its benefits, legal system and judicial system. The course will help students understand specific character of the European Union as a unique organisation which draws inspiration from the functioning of both international organisations and federations. Students will learn how EU law is applied in the Member States, how individuals can invoke it and

how EU law is enforced. Secondly, attention will be paid to internal market freedoms and competition law, i. e. the core of substantive law of the EU. The internal market freedoms represent the greatest achievement of European integration as well as a major benefit of EU membership. Thus, the four freedoms – free movement of goods, persons, services and capital - will be explained in more detail. The freedoms are closely linked with competition law because competition rules have special role in the EU: to protect the internal market. Students will analyse case-law of the Court of Justice of the EU, solve fictional cases and quizzes in order to better understand the basics of EU law.

ONLY FOR MA STUDENTS: Contemporary Challenges to Political Parties and Party Representation

ECTS: 4

Course description:

This course concentrates on the emergence, functions, organization, and future prospects of political parties in modern (mainly European) representative democracies. Political parties are one of the central actors of modern representative democracies. They represent views of citizens and link them with democratic institutions. They play a crucial role in interest aggregation and articulation of societal demands. They are essential actors in competitive elections. They also organize working of parliaments and governments. And, finally, parties recruit candidates for public offices and governing institutions. In many respects, therefore, parties seem indispensable for democracy. However, the legitimacy and functioning of political parties are also increasingly challenged by parties' increasing unpopularity with citizens, the rise of populism and political polarization, and some democratic innovations including radical reforms of democratic institutions. The course will employ both the classic and modern academic literature on the role of political parties in order to explore in detail key challenges parties face in contemporary representative democracies, and the consequences of these challenges for political representation and democracy.

Block-taught courses of visiting professors with a limited number of enrolled students:

Current political changes in Europe: problems, challenges, insights. What is the future?

ECTS: 4

Course description:

This course aims on envisaging the political situation in Europe since the collapse of the Soviet Union in 1991. The last more than 30 years were absorbed with different dilemmas and unpredictabilities, a few of which are still unresolved. Most obvious in this regard is the political situation around the former Soviet Union and the consequences after its collapse. The situation originated a new set of hardships including territorial, political, economic etc., which influence not only the European space but far beyond. They concern, in particular, political management as such, the issues of national identity, modern emigration, economic instability and many others. This demands, at least, a more scrupulous investigation of the contemporary situation in Europe, given main political and economic interests of this conglomerate and separate countries in particular. Military conflicts that occurred in Europe this time are supposed to be a part of this agenda. This volumable analysis will enable to better see the future evolution of Europe and its readiness to confront with current obstacles and challenges being painful for its development. The course looks as suitable for students of different specialties, and develops their knowledge in humanities regarding history, politics and cultural studies.
